- probability of adverse effects on the human health.
- The assessment was made in accordance with the principles of Good Laboratory Practice and Good Manufacturing Practice (GLP, GMP), the conditions for manufacturing and storage without causing any damage to the consumer's health in normal and predictable use and if the cautionary notes and instructions for use are followed.  
Chemical signs, toxicological parameter, and level of raw materials used in the end product composition were considered.

The cosmetic products do not contain any ingredients classified as carcinogenic, mutagenic, or toxic for reproductive system (CMR) and classified as Categories 1A, 1B, and 2 according to Regulations (EU) No. 1272/2008.

The cosmetic products do not contain any ingredients obtained from genetically modified

plants and animal-derived products.

The cosmetic products have not been tested on animals.
